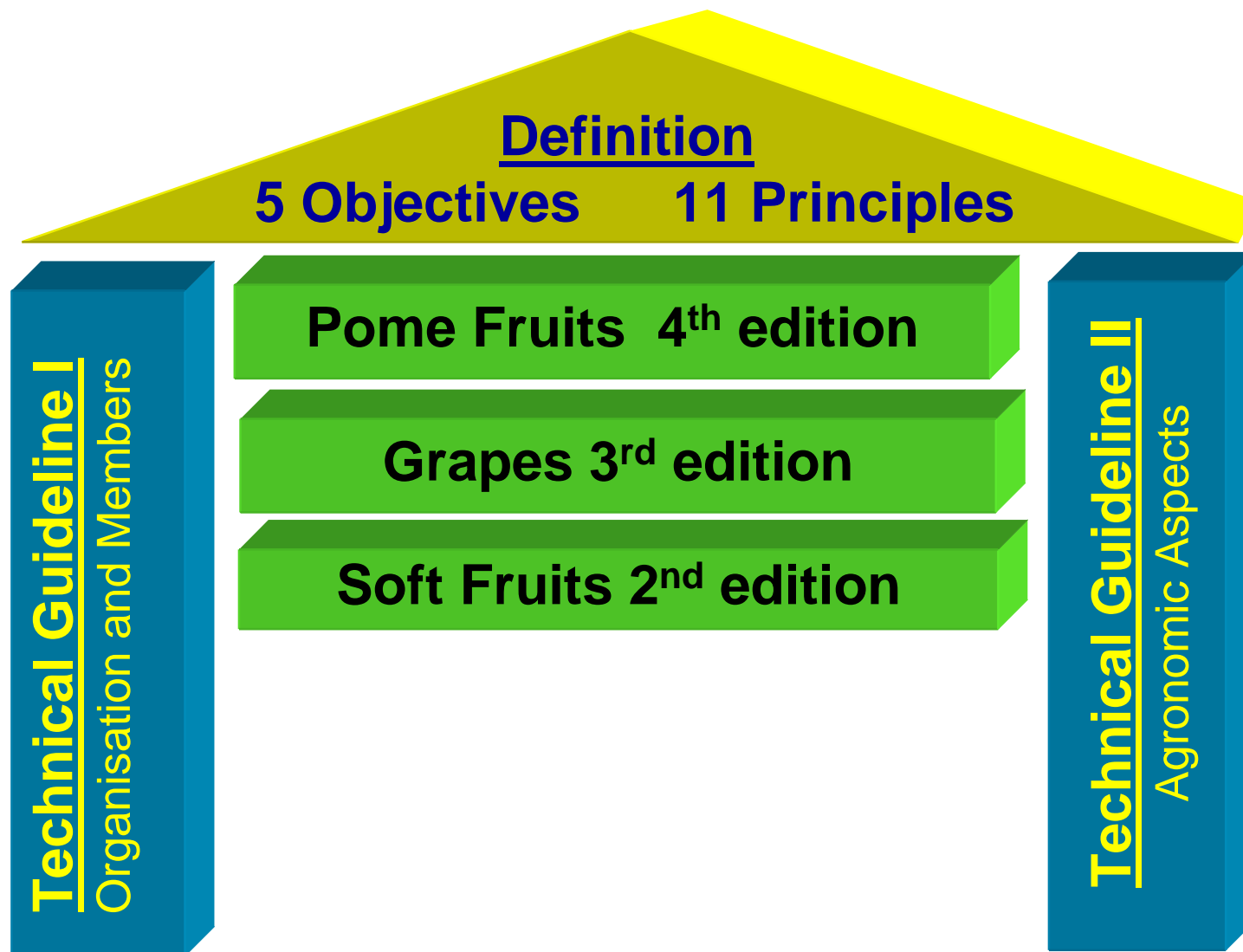

# Provide conceptual frame for IOBC standards of Integrated Production

- **AREFLH** (Association of the European Regions that produce Fruits and Vegetables)
  - **proposal of EU regulation on IFP**
  - **asked by European commission representatives involved in Fruit & vegetables Common Market Organisation**
- **EC Green paper on agricultural product quality**
  - **A report has is available in internet.**
  - **Integrated Production is not mentioned in it.**
  - **IP is not seen in the EU as a new quality scheme, but as the new standard for subsidies.**

# Provide conceptual frame for IOBC standards of Integrated Production

- **EC Expert group on the Thematic Strategy on the sustainable use of pesticide**
  - **First meeting in Bruselles (2009)**
  - **Possible standard for both mandatory and agroenvironment level establishment.**
- **EU funded study on IPM (BiPro)**
  - **Mainly directed at competent authorities**
  - **Guidance for establishing IPM principles**
  - **Thematic Strategy on the Sustainable use of Pesticides**

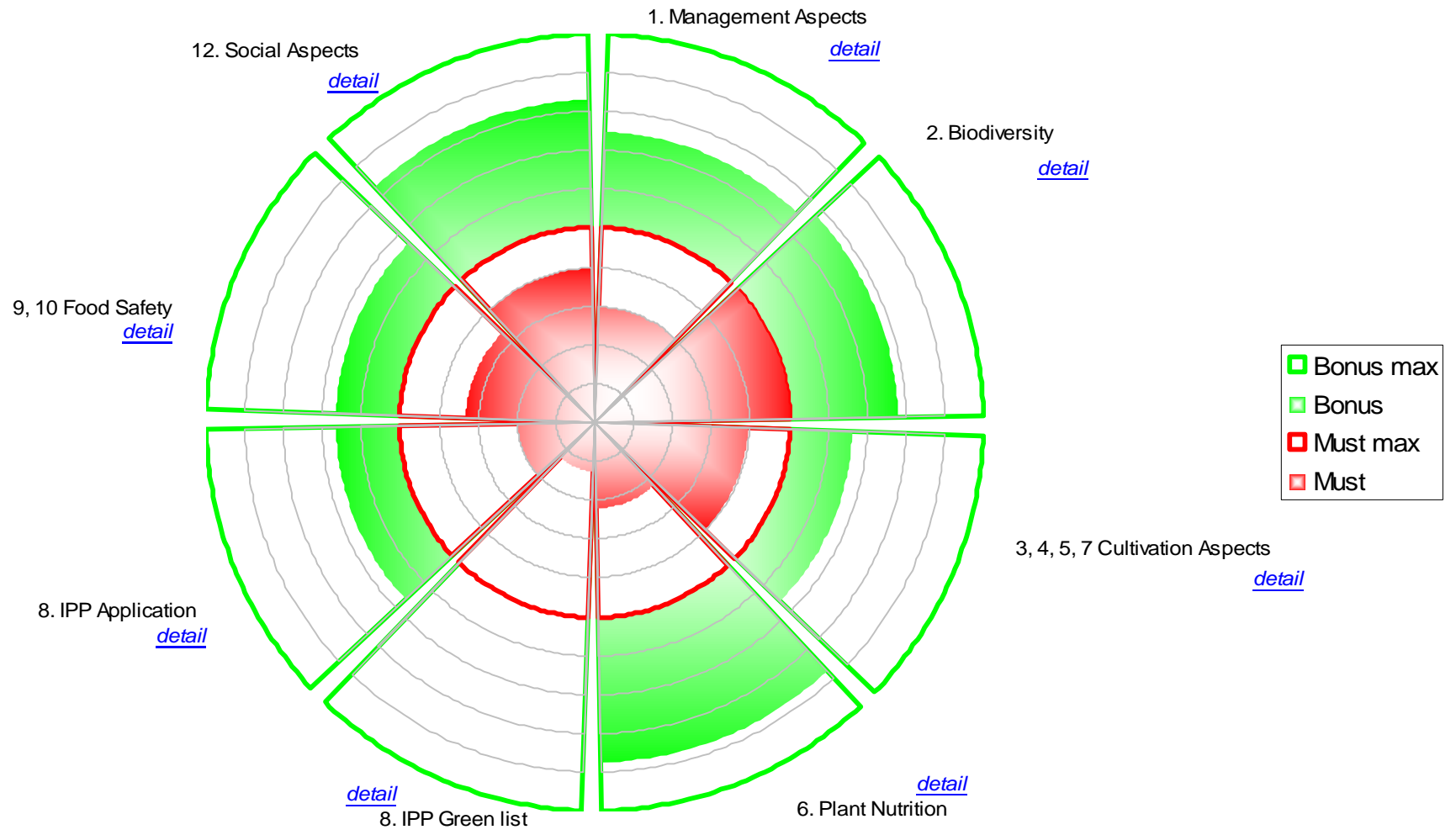

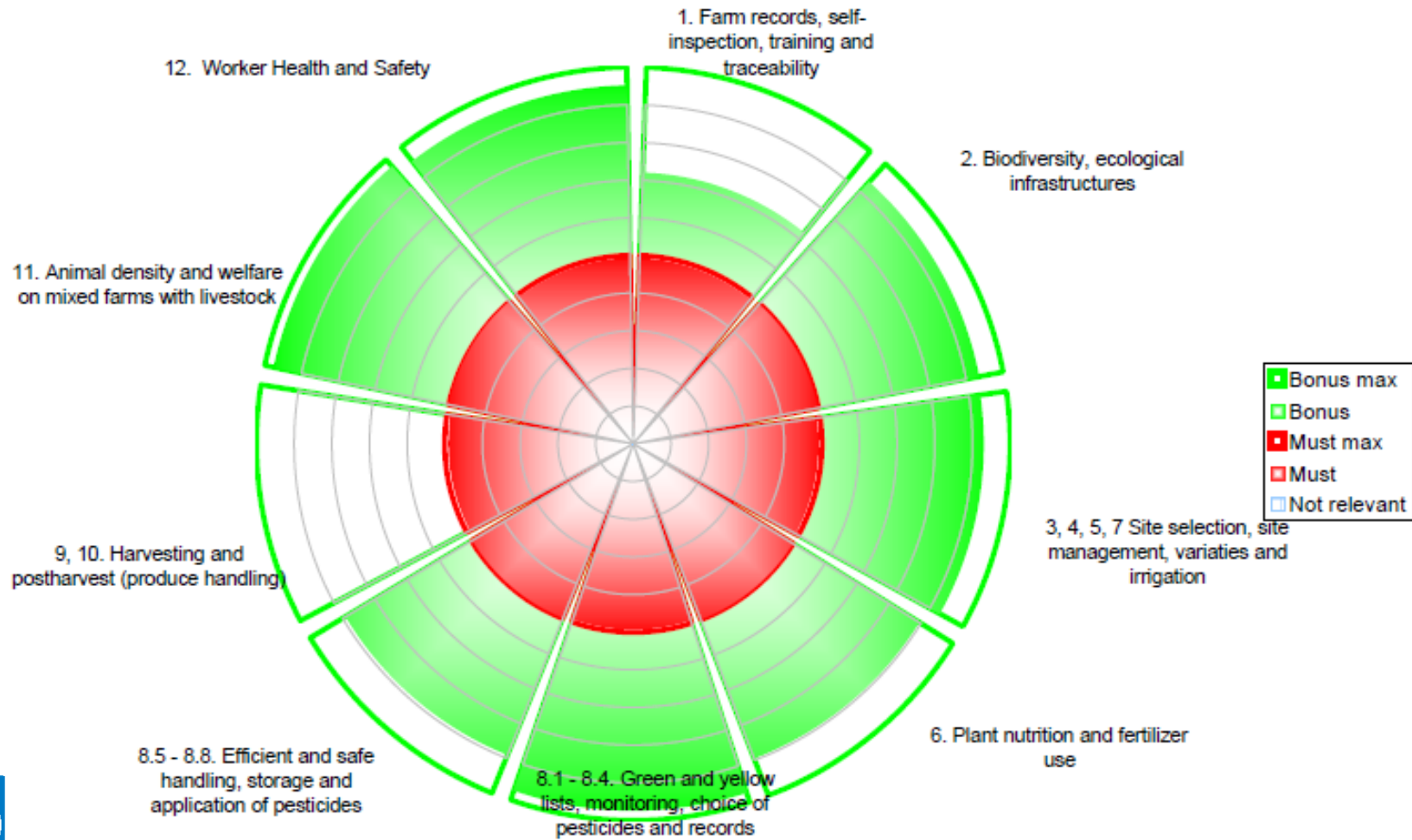

Farm performance of IOBC Standard for Integrated Production

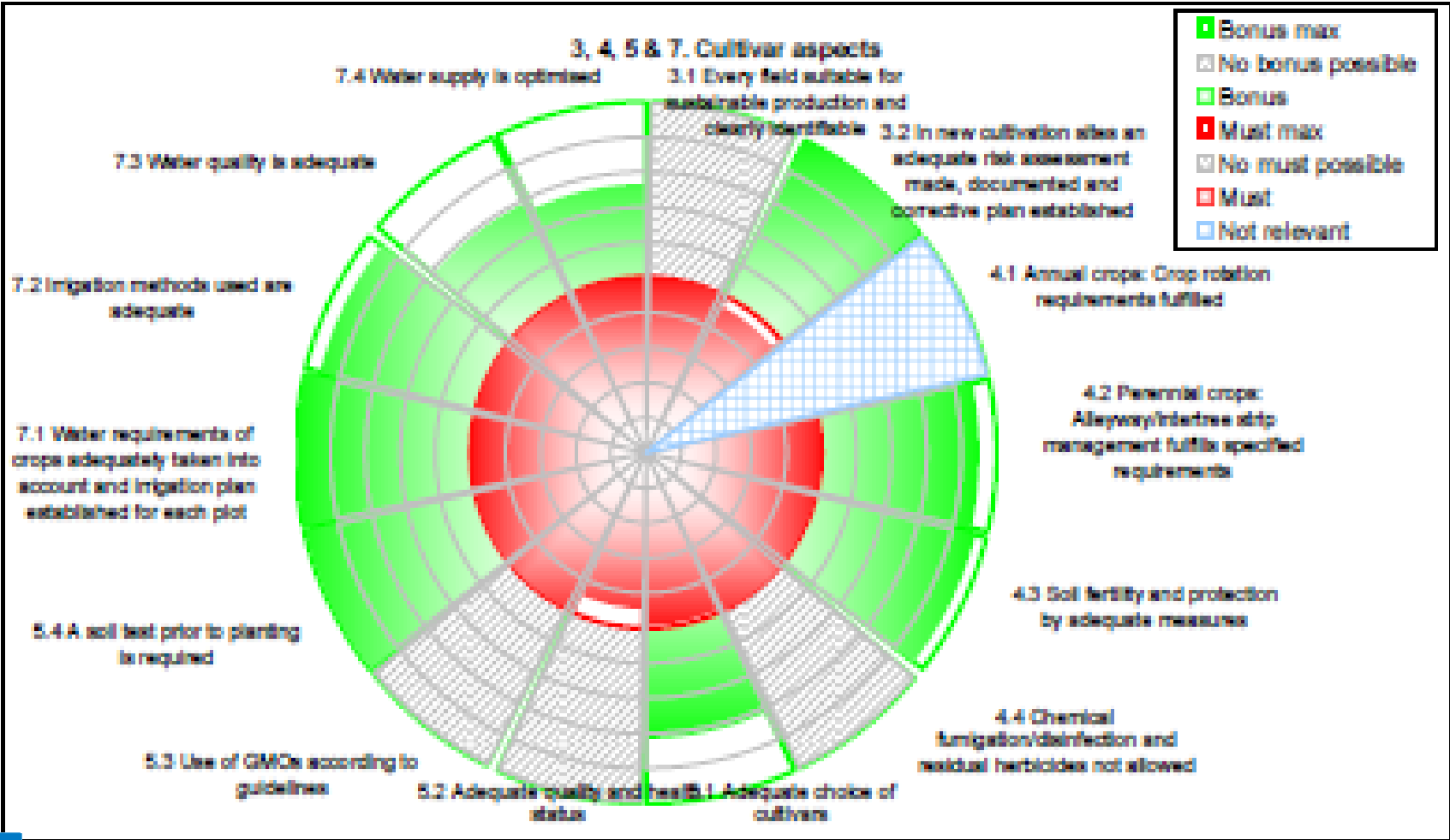
